



## Viridian Retrofit

### Q Card 18 Months Interest Free

#### Terms and Conditions

This promotion is open to individual non-commercial customers who order five or more Viridian Retrofit windows (**Windows**) for installation in a single residential building in New Zealand from Viridian Glass LP (**Viridian**), or its trading division Rocket Retrofit (**Qualifying Purchases**), between 17 February and 30 April 2025 (**Promotional Period**).

Under this promotion customers who retrofit 5 or more Windows and spend at least \$3,000 including GST will be eligible to apply for finance on their purchases with an initial 18-month interest free period.

Finance is provided by the Humm Group, including Consumer Finance Limited and / or Columbus Financial Services Limited to eligible Q Card, Q Mastercard, Farmers Mastercard and Flight Centre Mastercard cardholders. Their full terms and conditions, lending criteria and approval processes will apply. New customers will need to apply and be approved for a Q Mastercard credit card to be eligible for this promotion.

Customers purchasing with finance will be required to pay for the retrofit of the Windows in full upon placing an order for the Windows or accepting a quote, unless Viridian agrees otherwise in writing with the customer prior to an order being placed.

18 months interest free is available on Long Term Finance (**LTF**) for in-store purchases only until 30 April 2025. Minimum spend \$3000, including GST. Third-party lending criteria, \$50 annual Account Fee, fees, lending terms and conditions apply. \$55 Establishment Fee applies to your first LTF transaction, \$35 Advance Fee applies to subsequent LTF transactions. Minimum payments of 3% of the monthly closing balance or \$10 (whichever is greater) are required throughout interest free period. Paying only the minimum monthly payments will not fully repay the loan before the end of the interest free period. Standard Interest Rate of 28.50% p.a. applies to outstanding balance at the end of LTF Interest Free Period. Rates and fees are based on information provided to Viridian by the lender, subject to change. Other interest rates and fees may apply. All installation work relating to the retrofit windows (including existing window removal) must be carried out by Viridian and / or its agents or contractors for the customer to be eligible to participate in this promotion. This promotion does not apply to customers who are purchasing materials only or who are using third-party installation services.

Unless expressly agreed with Viridian in writing, the customer shall be responsible for obtaining any necessary consents, code compliance certificates or other approvals for design or building work that are required. Unless otherwise agreed in writing, the costs of those steps are not covered by this promotion and are not subject to the finance offer above.

This promotion is only for the retrofit and replacement of existing glass in an existing residential dwelling or other residential building (including houses, townhouses, exterior garages or single units within an apartment or multi-unit building). Purchases for multi-unit buildings, unit title developments, commercial premises, new builds or installations or renovations requiring changes to the building design, group purchases, and purchases by or for a body corporate are excluded.

All Windows must be ordered from Viridian in a single transaction within the Promotional Period. Past and future orders cannot be combined for the purposes of this promotion. This promotion will not be available to customers requesting installation date(s) after 30 June 2025 unless Viridian expressly agrees otherwise in writing with the customer prior to the customer's order or acceptance of any quote for the Windows.

This promotion is available only once per customer and only once per property.

This promotion is subject to limited product availability, the suitability of the product for installation in the customer's building, and limited availability of Viridian staff and / or contractors for installation work. Viridian reserves the right to decline any order for any reason in its sole discretion. To the fullest extent permitted by law, in no circumstance shall Viridian have any liability to the customer if it elects not to enter a contract for supply for any reason (in contract, tort or otherwise).
